1. Welcome & introductions

2. Report on tasks

a. MH successfully reestablished TNA Committee Google Group.

b. Strategy for approaching uni leadership (All)

- JN circulated draft PowerPoint presentation for “pitching” TNA to management etc.
- All agreed it was a very useful tool that can be further evolved/refined.
- **ACTION (Further suggestions/contributions by All)**

c. Legal structure (VG)

- Postponed until membership definitions/types/classes resolved.

d. Membership classes (MH)

- MH asked for discussion about membership models and voting mechanisms for determining TNA representative committee.
 - Consensus for retaining an inclusive “self-identified tech” class of membership. Free?
 - Consensus for a distinct “voting rights” membership. Eligibility? Cost?
 - JN – 1 vote/uni?
 - 40 Australian uni’s (37 public and 3 private) + 2 international private uni’s.
 - VG – Do TNA challenges vary geographically e.g. state to state, region to region?
 - VG’s view is that they do not.
 - RJ – Favours a broad voting base i.e. not restricted to institutional votes.
 - PS – Suggested committee makeup be Chair + 2 reps/state for a fixed 2yr term.
 - NT and Tas each have 1 uni. The ACT has 2
 - VVD- Pointed out that TNA presence and membership at UoS and UTS is not strong.
 - Support of TNA and its activities varies widely.
 - Concern that if institutions have votes that they would assign managers as their reps.
 - KT – Do not outsource control (away from membership base); Gender spread of committee? Favours 2yr committee cycle
- **ACTION (MH)** to distribute some membership type options prior to next meeting

- ACTION (PS) to survey committee re document platform preferences e.g. Dropbox, OneDrive etc.

- Highest priority is to gain top-down support for TNA within university sector.
 - Formalising TNA structure will add credibility and recognition.
